From the introductory Cargo Aviation Security Principles course, through to the Cargo Manager course, all of our programmes are conducted in an interactive style, encouraging discussion and raising awareness of the risks associated with complacency.

All of our courses feature extensive visual aids, real-life scenarios and reinforce the need for constant vigilance.

Written tests are carried out at the end of each course to confirm participants understanding. Refresher training is required every two years for all courses, and the National X-ray CompetencyTest (NXCT) is required every 13 months for X-ray Operators. Throughout our training programmes, much emphasis is placed upon encouraging a culture of security awareness in the workplace.
