Dear Shareholders

Recommended cash offer for Mitie Group plc (“Mitie”) by OCS Group International Limited (“OCS”) – Publication of Scheme Document

On 21 July 2026, the boards of Mitie and OCS announced that they had reached agreement on the terms of a recommended cash offer for the entire issued, and to be issued, ordinary share capital of Mitie (the “**Acquisition**”). The Acquisition is to be effected by means of a Scottish Court-sanctioned scheme of arrangement under Part 26 of the Companies Act 2006 (the “**Scheme**”).

The next step in the process is for the Court Meeting and the General Meeting of Mitie’s shareholders to take place on 16 September 2026, at which shareholders will be asked to approve the Scheme and, by extension, the Acquisition. Further details are set out below.

The purpose of this letter is to notify you that a circular relating to the Scheme (the “**Scheme Document**”) was published today and has been made available to you (subject to certain restrictions relating to persons resident in restricted jurisdictions) on Mitie’s website at www.mitie.com.

The Scheme Document sets out, amongst other things, a letter from the Chair of Mitie, the full terms and conditions of the Scheme, an explanatory statement, notices of the shareholder meetings, an expected timetable of principal events and details of the action to be taken by Mitie Shareholders. Terms used in this letter and not defined herein have the meanings given to them in the Scheme Document.

Mitie Shareholders will find enclosed with this letter the following important documents in relation to the shareholder meetings relating to the Scheme in hard copy:

- a BLUE Form of Proxy for the Court Meeting; and
- a WHITE Form of Proxy for the General Meeting.

If you have not received all of these documents, please contact Mitie’s registrar, MUFG Corporate Markets, on the Shareholder Helpline referred to below.

The full text of the Scheme Document and all other information, documents and announcements relating to the Acquisition will remain available during the course of the offer period on Mitie's website at www.mitie.com.

Shareholder Meetings

In order to become effective, the Scheme requires approval at two meetings – the Court Meeting and the General Meeting – both of which will be held at Level 12, The Shard, 32 London Bridge Street, London, SE1 9SG, on 16 September 2026. The Court Meeting will start at 11.30 a.m. (London time) and the General Meeting at 11.45 a.m. (London time) (or as soon thereafter as the Court Meeting has concluded or been adjourned).

Action to be taken

Mitie draws your attention to the "Action to be taken" section on pages 11 to 15 and Section 18 of Part Two (Explanatory Statement) of the Scheme Document for details of how to vote and the relevant deadlines for voting if you are entitled to attend and vote at the Court Meeting and/or the General Meeting. The Notice of Court Meeting is set out at Part Ten (Notice of Court Meeting) of the Scheme Document. The Notice of General Meeting is set out in Part Eleven (Notice of General Meeting) of the Scheme Document.

This letter is not to be taken as a summary of the information in the Scheme Document and should not be regarded as a substitute for reading the Scheme Document in full. Please read the Scheme Document and other documents sent to you carefully.

Appointment of a proxy – please appoint a proxy as soon as possible

It is important that, for the Court Meeting in particular, as many votes as possible are cast so that the court may be satisfied that there is a fair representation of shareholder opinion. Whether or not you intend to attend and/or vote at the Court Meeting and/or General Meeting, you are strongly urged to complete, sign and return your forms of proxy (by post, online or electronically) as soon as possible and as described in more detail in the Scheme Document.

To appoint a proxy by post, please complete and sign the Forms of Proxy in accordance with the instructions printed thereon and return them to MUFG Corporate Markets, Mitie's registrar, by post to PXS 1, Central Square, 29 Wellington Street, Leeds, LS1 4DL.

Proxies may be appointed electronically by logging on to www.mitie-shares.com and following the instructions therein. It will be necessary for a Scheme Shareholder and Mitie Shareholder to register using their Investor Code (IVC) printed on their BLUE or WHITE Form of Proxy. Full details of the procedures are given on the website.

If you hold your Mitie Shares in uncertificated form (i.e. in CREST), you may appoint a proxy using the CREST electronic proxy appointment service in accordance with the procedures set out in the CREST Manual. Proxies submitted via CREST (under CREST participation ID RA10) must be received by MUFG Corporate Markets not later than 48 hours (excluding any part of such 48 hour period falling on a non-working day) before the time appointed for the relevant Meeting.

If you are an institutional investor, you may also be able to appoint a proxy electronically via the Proxymity platform, a process which has been agreed by the Company and approved by the Registrar. For further information regarding Proxymity, please go to www.proxymity.io. Your proxy must be lodged no later than 48 hours (excluding any part of such 48 hour period falling on a non-working day) before the time appointed for the relevant Meeting. Please refer to the Scheme Document for detailed information about how to appoint proxies by post, online or electronically.

You are reminded that to be valid, your proxy vote must be received by MUFG Corporate Markets not later than 11.30 a.m. (London time) on 14 September 2026 for the Court Meeting and 11.45 a.m. (London time) on 14 September 2026 for the General Meeting or, if in either case the meeting is adjourned, the relevant form of proxy should not be received

later than 48 hours (excluding any part of such 48 hour period falling on a non-working day) before the time fixed for the adjourned meeting. No form of proxy will be accepted at any time if it is found to contain a suspected computer virus.

If the BLUE Form of Proxy for the Court Meeting is not lodged by the relevant time, it may be handed to MUFG Corporate Markets, Mitie's registrar, or the Chair of the Court Meeting before the start of the Court Meeting (or any adjournment thereof). However, if the WHITE Form of Proxy for the General Meeting is not lodged by the relevant time, it will be invalid.

Dealing and opening position disclosure requirements

Under Rule 8.3(a) of the Takeover Code, any person who is interested in 1 per cent. or more of any class of relevant securities of an offeree company or of any securities exchange offeror (being any offeror other than an offeror in respect of which it has been announced that its offer is, or is likely to be, solely in cash) must make an Opening Position Disclosure following the commencement of the offer period and, if later, following the announcement in which any securities exchange offeror is first identified. An Opening Position Disclosure must contain details of the person's interests and short positions in, and rights to subscribe for, any relevant securities of each of (i) the offeree company and (ii) any securities exchange offeror(s). An Opening Position Disclosure by a person to whom Rule 8.3(a) applies must be made by no later than 3:30 p.m. (London time) on the 10th business day following the commencement of the offer period and, if appropriate, by no later than 3:30 p.m. (London time) on the 10th business day following the announcement in which any securities exchange offeror is first identified. Relevant persons who deal in the relevant securities of the offeree company or of a securities exchange offeror prior to the deadline for making an Opening Position Disclosure must instead make a Dealing Disclosure.

Under Rule 8.3(b) of the Takeover Code, any person who is, or becomes, interested in 1 per cent. or more of any class of relevant securities of the offeree company or of any securities exchange offeror must make a Dealing Disclosure if the person deals in any relevant securities of the offeree company or of any securities exchange offeror. A Dealing Disclosure must contain details of the dealing concerned and of the person's interests and short positions in, and rights to subscribe for, any relevant securities of each of (i) the offeree company and (ii) any securities exchange offeror(s), save to the extent that these details have previously been disclosed under Rule 8. A Dealing Disclosure by a person to whom Rule 8.3(b) applies must be made by no later than 3:30 p.m. (London time) on the business day following the date of the relevant dealing.

If two or more persons act together pursuant to an agreement or understanding, whether formal or informal, to acquire or control an interest in relevant securities of an offeree company or a securities exchange offeror, they will be deemed to be a single person for the purpose of Rule 8.3.

Opening Position Disclosures must also be made by the offeree company and by any offeror and Dealing Disclosures must also be made by the offeree company, by any offeror and by any persons acting in concert with any of them (see Rules 8.1, 8.2 and 8.4).
